FUGITIVE CHECK MISSING PERSONS BOP

Sec. 11-16. Required.

It shall be unlawful for any person, either as a principal, or as agent for any other person to go in or upon any premises occupied for residential purposes within the City for the purpose of soliciting or canvassing from any occupant thereof orders for goods, wares, merchandise or services, or for the purpose of offering to give or furnish any article or service in order to obtain such order, without first having applied for and received from the Chief of Police a solicitor's permit to do so.

Sec. 11-17. Registration

- (a) Any person, either as a principal, or as an agent for any other person or organization who proposes to perform the activities described in § 11-16 of this article shall apply for an initial registration with a Chief of Police or his/her designee.
- (b) In the event that the City of Pittsfield is the City for which initial registration is being sought, each applicant for such initial registration shall:
 - (1) Provide positive identification
 - (2) Give a permanent street address
 - (3) Provide an exemplar of his/her signature
 - (4) Provide the name of his/her employer or the party responsible for satisfying the obligations, if applicable
 - (5) Provide the business address of such employer, if applicable;
 - (6) Provide the identity and registration of any motor vehicle to be used to transport goods, wares, and/or merchandise or persons engaged in business of transporting such goods, wares, and/or merchandise; and
 - (7) Provide a brief description of the goods, wares, and/or merchandise to be sold and the proposed method of operation
- (c) In the event that the City of Pittsfield is the City for which initial registration is being sought, the Chief of Police or his/her designee shall photograph each applicant for the purpose of identification and shall retain a copy of each such photograph for a minimum of two years.
